COOKIE FILE POLICY

1. PRELIMINARY PROVISIONS

1.1 This policy refers to cookie files (hereinafter referred to as "Cookie Policy") and is developed by "Work n roll" Company hereinafter (referred to as the "Company", "we", "our", "us").

- 1.2 The website worknroll.pro, cabinet.worknroll.pro and the Work'n'Roll mobile applications (hereinafter referred to as "The Platform") are operated and provided by "Work n roll" Company.
- 1.3 The terms "User", "you", "your" mean users and/or clients of the Platform and/or party to a transaction.
- 1.4 This Cookie Policy is published by the Company to help Users of the Platform to acquaint themselves with our rules regarding Cookie Files. In a transparent and open way we inform Users about how and when we gather and use Cookie files.

2. COOKIE FILES AND SIMILAR TECHNOLOGIES

Gathered information regarding, among others, the IP address, used internet browser, language, operating system, internet services provider, information about the time and date, location and other technical parameters.

We want our Users to enjoy using our Platform, products and services for the User to be able to find interesting products and to enable us to design our website in a way that it's user friendly, we analyse the user's behavior while using the website in an anonymous or pseudonymized manner. Below, we present general information regarding different purposes of use of such information. We want to draw your attention to the fact that some cookie files are necessary for the Service and/or providing services to work, therefore use of such cookie files cannot be rejected.

- 2.1 The following Cookie Policy describes our information practices regarding the use of our Work'n'Roll Platform and all of our products and on-line services (also referred to as the "Platform").
- 2.2 This Cookie Policy has to be understood as an integral part of Privacy Policy of Work'n'Roll Platform, published in other sections of the Platform.
- 2.3 Cookie Files are small text files containing unique identifiers which are sent by the server to the computer, mobile phone or other devices with access to the internet while using the Platform. We use Cookie files to distinguish between you and other users of our Platform. It helps us to provide you with an enjoyable experience while visiting our Platform.
- 2.4 By continuing to use the Platform you consent to the use of Cookie Files by us.
- 2.5 This Cookie Policy regards to Cookie Files, but we may also use other, similar technologies in the same way.

3. HOW DO WE USE COOKIE FILES

3.1 We use Cookie Files to register information about the session and to provide our Services.

We use this information to make decisions regarding the ways to improve offered Services, simplify browsing and to ensure more personalised Services, Adjust recommendations and adverts shown on our Platform, to conduct our own analysis which helps us develop and improve our Platform.

3.2 On our Platform we use all or some of the following categories of

Cookie Files:

- (a) Basic Cookie Files Those Cookie Files are necessary for the proper operation of some parts of our Platform. They allow you to move through the Platform and help us distinguish you from other users of our Platform. To enable us to provide you with the requested service, for example remembering registration information.
- (b) Functional Cookie Files. Those Cookie Files help us adjust the contents of our Platform to your preferences. They remember your settings, language, country from which you gain access to our Platform. Information gathered by these Cookie Files can be anonymous and cannot trace your activity on other websites.
- (c) Productive Cookie Files. These Cookie Files gather information on how you use our Platform, to help us improve areas like navigation and to help us repair technical problems and errors. For example, we use these Cookie files to understand how you gain access, brows and use our Platform, which areas we highlight and which we can improve. Information stored in those Cookie Files never present personal data, which would enable us to determine your identity.
- (d) Targeted Cookie Files These Cookie Files gather information about your browsing routines which means delivered adverts and content is more well suited for you and your interests. They're also meant to limit the number of times an ad or other content is shown, as well as, to measure the effectiveness of marketing and advertising campaigns.

Files are usually hosted by external advertising networks. They remember visited websites and that information is forwarded to other entities, such as advert providers.

3.3 Gathered information regarding, among others, the IP address, used internet browser, language, operating system, internet services provider, information about the time and date, location and other technical parameters.

4. BLOCKING COOKIE FILES

4.1 At any time you can block the use of Cookie Files in your internet browser. The instructions regarding blocking, deleting and turning off Cookie Files can be found in the "Help" "Technical Support" sections of a browser. Remember that deleting Cookie Files or turning them off in the future will make it impossible to use some sections and functionalities of our Platform.

- · implement of marketing campaigns,

· ensure security standards.

We use "permanent" and "session" cookie files. "Permanent" cookie files are left in the internet browser of the device until they are deleted by the user or until set time determined by cookie file parameters. "Session: cookie files are left in the browser until it is closed or the user logs out of the website where the cookie files were placed.

6. FINAL PROVISIONS

6.1 From time to time we may change and/or update this Cookie Policy. Updated and/or modified versions of Cookie Policy will always be published on the Platform. We recommend regular browsing of the platform to always be aware of information practices and any changes in them. Any and all changes to the Cookie Police come into effect at the moment of publication on the Platform.
